For many years, one could find Deloris near or around the Arts Building. She would help judge all of the beautiful quilts, radiant paintings, and delicious pies, etc. She would remain in the Arts Building many hours to make sure everyone's project stayed safe.

Deloris made sure the Fair was fair! She was there to help her fair community in every way that was needed.

The Fair was bred into Deloris. Her parents, Oscar and Lucille Kirchner were Fair Boosters and held the same box seats for over 50 years. Oscar also sat on the Fair Board.

Deloris and her husband Bob were dedicated 4-H leaders throughout the years. They raised their four children George, Noble, Roy, and Sara in the 4-H Club.

The kids have many memories of growing up in their warm and cozy home on the hill. There would be fresh vegetables on the table in the Summer and bounties of vegetables canned from their garden for the Winter.

Deloris would sew mounds of fabric scraps into beautiful works of art. They became quilts, every stitch done with love, to keep her family warm. This all made her more than qualified to be a judge at the Clark County Fair.

Deloris put her heart, soul, and backbone in each and every project.


She has passed on her knowledge and ethics to all of her children, her grandchildren, and all of her former students who were more than lucky to have had her... and many more who have crossed her path.
