Marshall Area Public Library District Annual Appropriation Ordinance

An Ordinance appropriating for all corporate purposes for Marshall Area Public Library District, Clark County, Illinois, for the fiscal year beginning July 1, 2023, and ending June 30, 2024.

Be It Ordained by the Board of Trustees of the Marshall Area Public Library District of Clark County, Illinois:

Section 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of said Public Library District, be and the same are hereby appropriated for the purposes of said Public Library District, as hereinafter specified, for the fiscal year beginning July 1, 2023 and ending June 30, 2024.

Section 2: That the appropriation herein made for any purpose shall be regarded as the maximum amounts to be expended under the respective appropriation accounts and shall not be construed as a commitment, agreement, obligation or liability of the Public Library District, and such appropriation being subject to further approval as to the expenditure thereof by the Board of Trustees.

Section 3: That the amount appropriated for each object and purpose shall be as follows:

tion, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

Section 6: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 3, for the fiscal year.

Section 7: That Section 4 shall be and is a summary of the annual Appropriation Ordinance of this Public Library District, passed by the Board of Trustees as required by law, and that this ordinance shall be in full force and effect from and after this date.

Section 8: That a certified copy of this Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.

Not less than prevailing rate of wages as found by the Illinois Department of Labor for Clark County, IL or determined by the court on review shall be paid to all workers under this contract.

All bids must be accompanied by a Bidder's bond, certified check, bank cashier's check or bank draft payable to the Marshall Public Library for ten percent (10%) of the total amount of the bid as provided in the Instruction to bidders.
