## Building and Maintenance Levy Ordinance 2024-25

An Ordinance To Levy And Assess A Tax For **West Union District Library** Of County Of Clark, State Of Illinois For The Fiscal Year Beginning July 1, 2024 And Ending June 30, 2025.

Be It Ordained, That the West Union District Library of the County of Clark and the State of Illinois shall levy a tax of .02% of the value of all taxable property within said District for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such tax, pursuant of 75ILCS 16/35-5.

Be It Further Ordained, that within fifteen (15) days from the date of adoption of the ordinance, it shall be published in the Marshall Advocate, a newspaper of general circulation in the West Union Library District, and it is effective immediately upon adoption.

In Witness Whereof, we have hereunder set our hands in West Union, Illinois this 21st day of May 2024.

1. The specific number of voters required to sign a petition requesting that the question of adoption of the ordinance be submitted to the electors of the district is 54.

2. The petition must be filed on or before June 28, 2024.

3. The referendum would be held on November 5, 2024.
