Annual Report Fiscal Year 2024

Dear Members of the Clark County Community:

In fiscal year 2024 (July 1, 2023 - June 30, 2024), the Clark County 708 Board has actively disbursed \$284,800.14 on behalf of community providers, dedicated to delivering essential mental health treatment and rehabilitation services to our valued residents in alignment with the Community Mental Health Act.

Marshall Area Youth Network (MAYN):

- Received \$19,276.02
- Supported school and community-based programs for children and adolescents dealing with alcohol, tobacco, and other drug issues
- Provided educational men-

toring programs, community engagement initiatives, and collaborative networking activities
Kids Club Summer Day Camp for Exceptional Students (Individuals with Disabilities):

- Received \$11,121.48
- Served children and young adults with intellectual and developmental disabilities
- Offered day camp services at no cost to participants
Human Resources Center of Edgar and Clark Counties (HRC):

• Received \$254,402.64 (including \$20,067.44 earmarked for Title XX Donated Funds Initiative 25% grant match)

• Services Provided to Clark County Residents by HRC:

- Mental Health Services: 2,472 hours provided to 412 residents (56% of total MH clients)
- Addiction Treatment: 1,048 hours provided to 121 residents (49% of SUD clients)

- Community Day Services: Served 10 Clark County residents

- Home-Based Services: Provided support to 1 resident

- Intermittent CILA: Served 4 Clark County residents

- Respite Services: Supported 7 Clark County residents

- Individual Placement & Support (IPS): Served 30 Clark County residents (50% of total IPS clients), showing significant growth from previous year

- Crisis Intervention Services: Provided immediate behavioral health support through the Living Room Program

- Special Olympics and community integration activities were expanded

- Addiction Prevention Education: HRC's Prevention Department served 356 Clark County students educating them about the dangers of drug use and alternatives.

Notable improvements from FY23 include increased IPS participation and expanded community integration activities. HRC has also strengthened its presence in Clark County schools and continues to develop partnerships with local stakeholders.

For the fiscal year ahead, the Clark County 708 Mental Health Board remains commit-

ted to supporting our community & mental health needs through strategic funding and partnerships.
