PUBLIC BID NOTICE

Invitation For Bids

The **Village of Hutsonville**, Illinois will receive Bids for a New Water Tower project until 9am CST, on the 26th day of June 2025 at the Village Hall, 113 South Main Street, Hutsonville, IL 62433 at which time and place all bids will be publicly opened and read aloud.

Bids are invited upon the several items and quantities of work as follows:

Construction of a 100,000 gallon water tower, a 6 inch water main connection and all related appurtenance, at 401 North Third Street, within the corporate limits of Hutsonville, Crawford County, Illinois. An alternate bid for a 75,000 gallon water tower will also be considered.

Contract Documents, including Drawings and Technical Specifications, are on file at the office of the Engineer, Stone & Waggoner, PLLC at 210 E. Locust Street, Robinson, IL 62454. The same documents will also be available at Southern Illinois Builders Association, O'Fallon, Illinois.

Electronic copies of the Contract Documents may be obtained for a non refundable payment of \$25.00 through the office of the Engineer. Paper copies of the same, may be obtained through the office of the Engineer upon non refundable payment of \$75.00.

A certified check or bank draft, payable to the order of Village Of Hutsonville, negotiable U.S. Government bonds (at par value) or a satisfactory Bid Bond executed by the Bidder and an acceptable surety in an amount equal to five percent (5%) of the total Bid shall be submitted with each Bid.

This project is funded in whole or in part with grant funds from the Community Development Block Grant (CDBG) program. Attention is called to the fact that 1) not less than the Federal prevailing wages as set forth in the Contract Documents must be paid on this project; 2) The work to be performed under this contract is subject to the requirements of Section 3, 24 CFR Part 75; and 3) The Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin.

Bidders must not be excluded from participating in any federal assistance program [24 CFR 85, Subpart C 85.35; 2 CFR 200.214].

The Village of Hutsonville reserves the right to reject any or all Bids or to waive any informalities in the bidding.

Bids may be held by the Village of Hutsonville for a period not to exceed 30 days from the date of the opening of Bids for the purpose of reviewing the Bids and investigating the qualifications of Bidders, prior to awarding of the Contract.
